# Storm is COMING.

ell, maybe not, but in the business of Public Works, you can never be too prepared to take on a devastating natural event, especially when thousands of our citizens are at risk. Despite the fact that we're still in a state of a drought, VCPWA is diligent in ensuring our teams are prepared and plan ahead to the best of our ability.

This month, our team carried out its annual Storm Day exercise, in conjunction with National Flood Preparedness Week. This year's theme was Fire & Rain. The Storm Day Exercise simulated flooding from a storm taking place after a simulated local brush fire. The exercise aimed to prepare our crew for landslides in canyons directly affected by fire season. Anytime heavy rainfall is forecasted, our teams are on high alert as these areas are greatly susceptible to debris flows, which can become dangerous for homeowners and their families residing in these regions, as well as motorists who travel the roadsides near these canyons.

For Flood Preparedness Week, the Board of Supervisors granted a proclamation recognizing the commemorative week, and VCPWA's Watershed Protection District created an informational exhibit which was on display at the Government Center. In addition, WPD provided tips for homeowners and residents that they can follow to help minimize losses in case of flooding.

#### SOME GOOD STEPS TO TAKE:

- Make an inventory of belongings and store that document out of the reach of floodwaters, preferably offsite perhaps in a safe deposit box.
- Raise appliances a foot or more above anticipated flood level.
- Learn how to acquire sandbags and also get familiar on how to place them to do the most good when floodwaters threaten your property.
- Make sure everyone in your family knows the plan: What is the evacuation route?

- Teach your family about the dangers of electric lines and floodwaters.
- Assign a relative or friend living away from you as an emergency contact and be sure everyone in your family has that contact information.
- Having enough food and water is essential to "get by" during a flooding emergency. So are cellphones, radios, batteries, flashlights, medical prescriptions, extra eyeglasses and basic first aid items. Be sure to store those supplies up high -- well above the anticipated flood level.
- Don't forget pets; they will need enough food to get by for the duration also.
- When making improvements to your landscaping, design with an eye toward flood protection as well as aesthetics. Retaining walls and other structures can help divert floodwaters.
- Purchasing flood insurance is a good idea too, since most home insurance policies do not cover flooding.

# Matilija Dam IN THE NEWS

Congresswoman Julia Brownley joined the VCPWA Watershed Protection District and other stakeholders to discuss a plan for the removal of the Matilija Dam due to its adverse impact on the local ecosystem and sediment build-up that has rendered the structure obsolete.

Following a tour of the dam, Secretary of the California Natural Resources Agency John Laird was the special guest at a roundtable discussion with key federal, state, local, and community stakeholders to identify strategies and specific plans for funding and actions needed to remove the dam and accommodate accumulated sediment. Senator Hannah-Beth Jackson (D-Santa Barbara), Assemblymember Das Williams (D-Carpinteria), and Ventura County Supervisor Steve Bennett also participated in the event.

Matilija Dam was built in 1947 on the Ventura River to provide a local water supply and flood protection for surrounding communities. However, over the past 70 years, sediment build-up behind the dam has significantly undermined the structure's intended functions. It also has impacted the ecosystems of Matilija Creek and the Ventura River, preventing natural sand and sediment flow to the beach, and preventing the endangered steelhead trout from reaching their ancestral spawning grounds.

"The District has been actively involved in the removal of Matilija Dam since 1999," said Peter Sheydayi, Ventura County Watershed Protection District Interim Director. "Today, 27 percent of the original steelhead spawning habitat in the Ventura River watershed lies locked behind the dam. A successfully completed project would remove the Matilija Dam and facilitate the natural flow of sand and sediment from the mountains to the beaches, also allowing the endangered steelhead trout to reach habitat upstream of the existing dam to the place of their ancestral spawning and rearing."
