he Ventura County Public Works
Agency Watershed Protection
District (VCPWA WPD) constantly
strives to protect homes, businesses, and
public facilities from flooding dangers
and damages. VCPWA WPD is currently
leading proactive efforts to improve the
levees south of Highway 101 known as the
SCR-3 Levee system in order to provide
adequate flood protection for about
3,800 structures located in North Oxnard.

SCR-3 currently does not have a unifying design required to protect these properties adequately during high-flow flood events. The neighborhoods affected by the project stretch from the Wagon Wheel development along Highway 101 heading west to Victoria Avenue and south to Gonzales Road along the south side of the Santa Clara River.

The complex undertaking is a two-phase project spanning four river reaches. Reach 4, which is closest to the Highway 101 Bridge, currently has a 2,500-footlong "gap" in flood protection. Reaches 1-3 continue downstream to the Bailard Landfill, where existing levees need improvements to meet federal standards.

With the Federal Emergency Management Agency (FEMA) planning to redraw SCR floodplain maps in the next few years,




VCPWA WPD hopes to have the SCR-3 levee improvements in place in time to avoid mandatory flood insurance for those with federally backed mortgages.

"The goal of the project is to close the gap in flood protection in Reach 4, improve the existing levees and stream bank protection in Reaches 1-3, and certify the levee system as meeting federal standards," said Gerard Kapuscik, Manager, Strategic Decision Support Group. "Once the levee improvements are constructed and accredited by FEMA, a typical homeowner with a federally backed mortgage will be spared the requirement to pay upwards of \$2,000 per year in annual flood-insurance premiums."

The public was given the opportunity to submit preliminary comments on the project on the VC Levee website or by mail. There will be more opportunities to comment as project planning progresses. All comments are valued and will be thoughtfully considered as the VCPWA WPD and City of Oxnard work collaboratively to refine project design alternatives and evaluate environmental impacts. Scheduling for the project is expected to occur over a 27-month period, beginning in late 2015 and ending in 2018. Construction will occur sequentially.




Proposed Site Renderings


